3. Bookings may be made by telephone but payment must be made in full by credit card.
4. All payments, including credit card, must be in sterling.
5. The Company reserves the right to cancel a booking if payment is not made three weeks prior to the conference taking place. Any outstanding payment becomes the responsibility of the signatory made on the booking form.
6. Payment of any booking made within three weeks of the conference will still be due to the company irrespective of whether the delegate attends.
